Turner International India Private Limited (**Turner**) is pleased to inform that effective April 01, 2018 (**Effective Date**), Turner has appointed IndiaCast Media Distribution Private Limited (**IndiaCast**) as Turner's exclusive authorized agent for distribution of television programming channels, namely, 'CNN International', 'Pogo', 'Cartoon Network', 'WB', 'HBO' and 'HBO HD' (**Turner Channels**) to distribution platforms in India. - (iv) any/all payments required to be made under new subscription agreement for Turner Channels shall be made in such account number as shall be intimated by IndiaCast in due course of time; and
- (v) any/all correspondences (including notices) pertaining to Turner channels shall be sent to IndiaCast at such office address of IndiaCast as may be relevant to your region.
